## Momina

I attended tutoring at Pathways regularly to help improve my grades, and the program also helped me become a more active volunteer. This gave me a lot of practical experience, and allowed me to meet other like-minded people and improve my networking skills.

Today, I'm about to enter my fourth year of study in Medical Physics, and my goal once I graduate is to gain work experience in the medical field. I'm so thankful for the help I received through Pathways to get me to where I am today. As an immigrant, it's quite difficult to network and gain exposure to opportunities, but Pathways really helps to bridge that gap. I feel like I'm able to achieve greater things because of Pathways.

#### **Future Ready**

Young people from low-income communities often face significant challenges that can make it difficult for them to get the proper knowledge, training, and skills they need to succeed in an increasingly competitive economy. Pathways hosts regular career workshops in locations across Canada designed to address these challenges and encourage students to think about their future career goals.

In 2018, youth at Pathways Vancouver participated in monthly speed mentoring sessions with professionals from a range of fields spanning technology, health, trades, social services, and finance. Youth were given the opportunity to spend 15 minutes with each professional, asking questions and making valuable connections. This career-focused event helped to create a dialogue between students and professionals, and allowed students to explore their post-secondary options in a comfortable and accessible setting.

#### Learning Life Skills

Through the Pathways Program, students build supportive relationships by engaging with their peers in group settings and working one-on-one with staff and volunteers. These activities help youth develop social competencies that lead to personal and professional success.

In partnership with Community Living Kingston, Pathways Kingston developed the Life Skills Program, an initiative to provide a formal setting for students to develop important life skills including time management, budgeting, and healthy nutrition. During weekly activities, students had the opportunity to join in meaningful discussions with facilitators, which helped to teach basic social skills and give students experience in successfully navigating interactions with their community and peers.



# IGHTS

#### Beating the Odds

Equity and inclusion continue to be key priorities for Pathways, and we remain committed to working with racialized youth to help identify and navigate the systemic barriers they face.

In partnership with Wilfrid Laurier University's Association of Black Students, Pathways Kitchener hosted Beating the Odds—an event for Black students designed to help reduce stigma and overcome barriers of accessing post-secondary education. Black artists and performers were featured throughout the day, and inspirational speakers took to the stage to share their experiences dealing with racism and advice for overcoming obstacles. Afterwards, students in attendance teamed up in small groups to discuss their own experiences, and left with practical tips to help defy stereotypes and achieve success.







#### First Steps to Success

Getting a foot on the employment ladder is an important first step towards a successful future, and Pathways locations across the country are working with youth to prepare them for the workforce.

Students at Pathways Saint John attended a job-readiness workshop where they learned tips on what to include in a cover letter and how to build their resume, with a focus on incorporating the transferrable skills they learn through the Pathways Program. Students also received practical job-seeking advice, including interview training and guidance on how to impress potential employers. The event helped students understand the importance of highlighting their skills in order to best position themselves within the job market.

#### Full STEAM Ahead

Last year, a new partnership between SHAD and Pathways was formed as part of a shared commitment to closing the opportunity gap for students in low-income communities.

SHAD supports the next generation of leaders in Canada through its life-changing, pan-Canadian enrichment platform for high school students. Every year, SHAD helps young Canadians tap into their full potential through an innovative month-long program at one of 16 partner university campuses.

Participating Pathways students received a full bursary, including travel to attend the program. Through SHAD's immersive-learning program, students got the unique opportunity to experience campus life while taking part in an ambitious schedule of STEAM-oriented labs, seminars, and handson workshops.





### Achieving Excellence Through Evidence

Pathways employs a continuous cycle of learning, evaluation, and improvement which allows for effective measurement of the impact that the program has on wider society. Pathways is proud of the positive results that have been highlighted and attributed to the program through both internal and external research.

In 2019, an independent study released by the National Bureau of Economic Research found that the Pathways Program can lead to meaningful, long-term labour market benefits for young people more than a decade after they participate in the program.

The report also found that youth in the Pathways Program experienced more success in post-secondary education and the workplace compared to their peers. Specifically, the report suggests that eligibility for the Pathways Program increased adult annual earnings by 19 per cent, increased the likelihood of being employed by 14 per cent, and reduced social assistance receipt by more than a third.\*

# CREATING OPPORTUNITIES FOR A BRIGHTER FUTURE

This year, Northbridge and Pathways are celebrating six years of impact together. During this time, Northbridge has been instrumental in helping Pathways alumni access critical social support through meaningful work experience.

Northbridge has developed a unique program that provides paid internship opportunities exclusively to Pathways alumni. In 2018, Northbridge provided internship positions in areas such as IT, finance, human resources, and project management. Paid internships give Pathways youth the opportunity to cultivate valuable skills in a career setting and establish a network of professional contacts across the organization.

Northbridge continues to bring their commitment to youth and education to life through this program, allowing young people who face significant barriers to broaden their career potential and possibilities.









During my internship at Northbridge, I developed communication skills and gained experience working in a professional office. That was something I hadn't been part of before, and it's an experience I'm proud of. I think it's important that Pathways alumni have access to these types of opportunities—they help us reach our professional and academic goals, and we really rely on them to get our foot in the door.



One of the hardest things about attending high school is feeling like you don't fit in. For the most part, all of junior high was like that for me. Then my mom found a Pathways flyer in our mailbox one day. She encouraged me to check it out, and I really enjoyed it—it got me out of my slump.

The program was important to me because it helped me to connect with my Aboriginal culture. They actually brought me to a sweat lodge where I received my spirit name, and from there I participated in more traditional cultural activities. It kept me busy, and having a transit pass allowed me to just hop on the bus and not have to worry about walking past any of the gangs or drug houses in the community.

The support from Pathways didn't end when I graduated from high school. I wanted to pursue a career in the trades, but I wasn't able to afford any of the work gear that I needed for the job. Pathways helped pay for a lot of the basics I needed for construction work, like ski pants and winter boots. They also helped me find one of my first housing units. They really helped me get on my feet, and now I give back to my community by volunteering with youth who experience the same struggles I did.

### SPOTLIGHT ON

### SUPPORTING MORE YOUTH IN QUEBEC

The high school dropout rate in some of Quebec's lowest income neighbourhoods can reach 50 per cent higher than the provincial average. The Pathways Program is currently delivered in six communities across the province, but there are many more that need support.

In 2017, the Quebec government announced their five-year plan for economic inclusion and social participation. With a goal to lift more than 100,000 people out of poverty by 2023, the plan includes the expansion of the Pathways Program in the province.

This commitment from the Quebec government will see Pathways double the number of young people served, and expand impact by opening new Pathways Program locations across the province. This support will also allow Pathways to continue tailoring programming to address the specific barriers Quebec youth face and provide students with the resources they need to succeed.



As we look ahead to the exciting Quebec expansion made possible through the generous support of the Quebec government, Pathways would like to say a special thank you to Rio Tinto, whose ongoing support paved the way for growth of the Pathways Program in the province. For the last 10 years, Rio Tinto has generously provided funding that has allowed Pathways students in Quebec to graduate from high school and succeed in their chosen post-secondary paths.

Rio Tinto's substantial long-term commitment allowed Pathways to launch programming in Mashteuiatsh, the only First Nations community in the Saguenay-Lac-Saint-Jean area. This support helped Pathways work alongside community organizations and institutions to adapt programming to better reflect the experiences of youth in Mashteuiatsh. Thanks to the ongoing support of Rio Tinto, Pathways will continue to strengthen community partnerships and focus on the development of culturally-relevant programming to support the personal and academic well-being of Indigenous youth in Quebec.

## FINANCIAL SUMMARY

MESSAGE FROM THE **TREASURER** AND **VICE-PRESIDENT**, FINANCE & OPERATIONS

The 2018-2019 fiscal year was one of financial growth for Pathways to Education. We achieved a second consecutive year of more than \$30 million of investment from our generous donors and government funders, and we continue to effectively balance being a lean organization while maintaining a strong level of financial stability.

Our financial position is solid and has allowed for strategic investment in select priority areas that are necessary for future growth and sustainability. We continue to fund Pathways Program Partners in amounts of more than \$20 million per year to allow for efficient and effective delivery of programming to students in local communities across the country. In response to the need for growth to support more young people, we increased investments in innovation and program development to \$2.9 million in total.

Even after increasing our investment in these key priority areas, we continue to operate at an exceedingly low administration rate, distributing more than 85 per cent of funds to areas directly impacting students and their families.

We look forward to continuing this momentum through careful and strategic fiscal planning over the next 12 months. We recognize that maintaining and growing the financial health of Pathways is key to fulfilling our mission of helping more young people build the foundation for a brighter future.



#### Summarized Financial Statements for the Fiscal Year Ending March 31, 2019




